

## **DocuBrain Workflow Editor**

The DocuBrain Workflow Editor is a WYSIWYG (What You See Is What You Get), drag and drop editor that let's you quickly build business processes using industry standard BPMN (Business Process Model and Notation).

The editor tightly adheres to the BPMN 2.0 standard and is custom tailored for the Activiti<sup>™</sup> workflow engine. It allows users the ability to graphically model business processes following the BPMN standard and deploy them directly to a running Activiti workflow engine like the one contained within TechDoc, our electronic document and records management product.

Using our collaborative process modeling, different users can create, view, and modify processes at the same time. A user can also connect to different process repositories during the same editing session.

The editor supports BPMN fragments. A fragment can contain an entire workflow or a small portion of a workflow that you frequently use. To create a fragment, simply place one or more elements onto a process diagram and save it as a fragment. To use it, simply click on the Fragments tab, then drag and drop the fragment onto the current process diagram.

The DocuBrain Workflow Editor provides model validation to locate errors early in the creation and modification process to reduce the chance of errors reaching production. Also, the editor tries to balance issue detection and reporting so that you are not bombarded with errors that result simply because you haven't complete the next step yet.

Our editor provides all the features you would expect in a quality editor; nearly unlimited undo/redo, alignment controls, grids, rulers, zooming, etc. We also provide lots of BPMN specific extras like form editing, XML source views, repository upload/download, and more.


